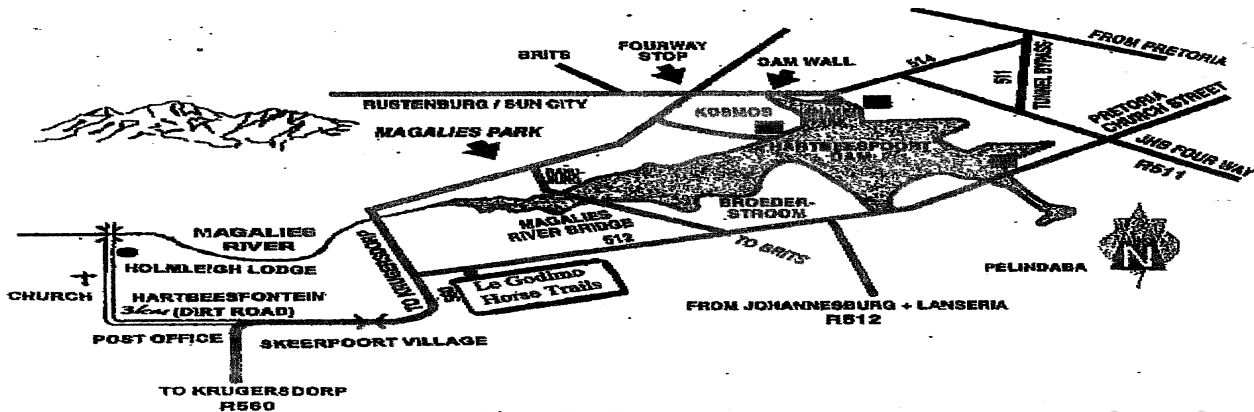
NO DOGS ALLOWED

General Rules and Conditions:

1. Classes 1 -14 will be run under SAEF and ESA Eventing rules 1st June 2010.
2. All tack will be checked before the commencement of each test as per Eventing Rules 45.4.2 & 45.7.3, protective head gear, medical cards and body protectors are obligatory for the Cross Country test. Surcingles are strongly recommended.
3. Competitors shall wear the correct dress at all times.
4. Protests lodged must adhere to Appendix GR/B of the SAEA General Regulations and Section 43 of the Eventing Rules.
5. The Organising Committee reserves the right to restrict class entries strictly on a first come first served basis.
6. Entries will only be accepted if accompanied with Proof of Payment - use Rider's name and initial as reference.
7. It is the competitors responsibility to make sure that their entries have been received.
8. The Show Holding Body reserves the right to alter or vary the programme in light of prevailing conditions at their discretion, with the approval of the Technical Delegate.
9. The Organising Committee, ESA, SAEF, Le Godimo and Sponsors cannot be held liable for any loss, damage, death or injury to people, horses or property whatsoever. All competitors and spectators enter the premises entirely at their own risk.
10. Ponies/Horses may compete from the 1 August of the calendar year in which they reach the age of 4 years for Eventing 0.80m and below and 5 years for Eventing 0.90m and Eventing 0.100m classes.
11. The Cross Country courses will be open for inspection on foot from 12h00 on Fri 7th Feb. This is regarded as the official starting of the event so all eventing rules will be enforced (including restrictions with regard to dress and saddlery). At the event venue and after the official opening of the courses for inspection, and the duration of the event, it is forbidden under penalty of disqualification for anyone other than the competitor who will ride the horse in the competition, to school the horse.
12. As from 10th November, no competitor/competing horse may ride in the vicinity of the cross country obstacles, until called upon to do so under penalty of elimination.
13. Numbers are to be collected before the Dressage Test and are to be worn for all 3 Tests. Bridle numbers are permitted.
14. Medical cards are compulsory and must be clearly visible on the rider.
15. Sponsors, owners, riders, horses and ponies must be registered with SAEF, ESA for 2013/14 subscription year as at the closing date of entry. Entries out of order at closing date will be forfeited.
16. A complete list of SAEF General Regulations, Veterinary Regulations, Eventing Rules and Eventing Dressage Tests can be found on the SAEF website www.eventingsa.co.za
17. All stallions must have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail.
18. Equine Flu Vacs must be administered within 6 months of the date of the event. AHS vaccinations must be in order.
