## General Rules and Regulations

1. No refunds will be made in respect of cancellations and scratching after closing date of entries
2. No horse may enter the event without up-to-date horse flu and AHS vaccinations. Passports must accompany horses
3. Approved dress code for dressage and show jumping is compulsory. Hard hats, body protectors, sleeved shirts (long or short), over girths and medical cards must be worn. Body protectors are available for hire at R20 per round; payable to the secretary on the day
4. All competitors are required to sign an indemnity form-to save time please fax or email with entry form
5. SAEF, ESA, Windsor House Event Centre, Sunshine Coast Eventing the organisers and any officials appointed by these shall in no way be held responsible for any damage, loss, or injury sustained by owners, competitors, members of the public or any other person or persons or their property at Windsor House Event Centre or Sunshine Coast Eventing for the duration of the event
6. The proposed programme with approximate times will be emailed once entries have been received
7. Late entries will be accepted at a 50% surcharge, time permitting
8. Insofar as possible the programme will be adhered to, however, the Technical Delegate reserves the right to make alterations in the event of unfavourable weather conditions or any other unforeseen circumstances. Depending on entries, classes may be combined.
9. All classes will be run according to current ESA eventing rules(June 2010.. All relevant rules apply (available at ESA website)
10. Horses and ponies must be 5 years (4 years for 80cm) and older.



## Indemnity
