## **GENERAL RULES AND REGULATIONS**

1. Hunter Trials will be run under the SAEF and Eventing South Africa rules updated 1 March 2015.
2. All tack will be checked before the commencement of each test. As per Eventing Rules 45.4.2 and 45.7.3, protective headgear, medical cards and body protectors are obligatory for the Cross Country test. Surcingles are strongly recommended.
3. Athletes shall wear the correct dress at all times whilst warming up and in the arena.
4. Objections lodged must adhere to Appendix GR/B of the SAEF General Regulations and Section 43 of the Eventing Rules.
5. The organising committee reserves the right to restrict class entries strictly on a first come basis.
6. **NO CHANGES BETWEEN CLASSES WILL BE ALLOWED AFTER THE CLOSING DATE OF ENTRIES.**
7. Entries will only be accepted if accompanied by proof of payment with the Rider's Name and Code as reference.
8. Any requests for a specific riding order **MUST** be clearly indicated on the entry form.
9. It is the responsibility of the athlete to make sure their entries have been received.
10. The Show Holding Body reserves the right to alter or vary the programme in light of prevailing conditions at their discretion, with the approval of the Technical Delegate. classes, riding times and competition days may be changed depending on the number of entries.
11. The Organising Committee, the Show Holding Body, Eventing SA, SAEF, and Treverton Trust cannot be held liable for any loss, damage, death or injury to people, horses or property whatsoever. All athletes and spectators enter the premises entirely at their own risk.
12. Ponies/horses may compete from the 1 August of the calendar year in which they reach the age of 4 years for Eventing 80 and below and 5 years for Eventing 90 and Eventing 100 classes.
13. The opening of the cross-country course signifies the start of the event and all eventing rules (including restrictions with regard to dress and saddlery) will be enforced.
14. At the event venue and after the official opening of the course for inspection, and for the duration of the event, it is forbidden under penalty of disqualification for anyone other than the athlete who will ride the horse in the competition to school a horse.
15. All entry forms must be signed.
16. As from the closing date of entries, no athlete/competing horse may ride in the vicinity of the cross-country obstacles, until called upon to do so under penalty of elimination.
17. Any horse that has not been officially entered for the event will not be allowed access to the grounds without prior permission from the Chairman of the Organising Committee.
18. Numbers are to be collected before the Dressage Test and are to be worn for all 3 Tests. Bridle numbers are permitted.
19. Medical cards are compulsory and must be clearly visible on the rider, preferably on the arm.
20. All stallions must have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail.
21. **EQUINE FLU VACS MUST BE ADMINISTERED WITHIN 6 MONTHS OF THE DATE OF THE EVENT.**
22. All paddocks, lunge arenas, and arenas are **STRICTLY** out of bounds, with the exception of clearly demarcated competition arenas.
23. No dogs allowed in the Wildlife area of Treverton.

## **CODE OF CONDUCT FOR THE WELFARE OF THE HORSE**

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
