## GENERAL RULES AND REGULATIONS FOR SAEF CLASSES

1. All classes will be run under SAEF and ESA Eventing Rules as 1<sup>st</sup> June 2010 updated 1 March 2015 and FEI Eventing. All tack will be checked before the commencement of each test. As per Eventing Rules 45.4.2 and 45.7.3 protective headgear, medical cards and body protectors are obligatory for the Cross Country test. Surcingle's are strongly recommended.
2. Athletes shall wear the correct dress at all times whilst warming up and in the arena.
3. Objections lodged must adhere to Appendix GR/B of the SAEF General Regulations and Section 43 of the Eventing Rules.
4. **Relevant subscription fees for your club, SAEF and ESA must be paid up before closing date of entries.**
5. The organizing committee reserves the right to restrict class entries strictly on a first come basis.
6. NO CHANGES BETWEEN CLASSES WILL BE ALLOWED AFTER THE CLOSING DATE OF ENTRIES.
7. Entries will only be accepted if accompanied by proof of payment with the Rider's Name as reference.
8. Any requests for a specific riding order MUST be clearly indicated on the entry form.
9. It is the responsibility of the athlete to make sure their entries have been received.
10. A complete list of SAEF General Regulations, Veterinary Regulations, Eventing Rules and Eventing Dressage Test can be found on the ESA website [www.eventingsa.co.za](http://www.eventingsa.co.za). No dressage test will be supplied so competitors must ensure that they have the correct copies.
11. The Organizing Committee, the Show Holding Body, EventingSA, SAEF & FEI and the Durban Shongweni Club cannot be held liable for any loss, damage, death or injury to people, horses or property whatsoever. All athletes and spectators enter the premises entirely at their own risk.
12. Ponies/horses may compete from the 1 August of the calendar year in which they reach the age of 4 years for Eventing 80 and below and 5 years for Eventing 90 and Eventing 100 classes.
13. The opening of the cross-country course signifies the start of the event and all Eventing rules (including restrictions with regard to dress and saddlery) will be enforced.
14. At the event venue and after the official opening of the course for inspection, and for the duration of the event, it is forbidden under penalty of disqualification for anyone other than the athlete who will ride the horse in the competition to school a horse.
15. As from the closing date of entries, no athlete/competing horse may ride in the vicinity of the cross-country obstacles, until called upon to do so under penalty of elimination. The Dressage Arenas are considered closed and out of bounds to all riders and horses competing in this event 4 days before the Event i.e. Monday 14 September 2015.
16. Any horse that has not been officially entered for the event will not be allowed access to the grounds without prior permission from the Chairman of the Organizing Committee.
17. Numbers are to be collected before the Dressage Test and are to be worn for all 3 Tests. Bridle numbers are permitted.
18. Medical cards are compulsory and must be clearly visible on the rider, preferably on the arm.
19. No dressage test will be supplied so athletes must ensure that they have the correct copies.
20. All stallions must have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail.
21. EQUINE FLU VACS MUST BE ADMINISTERED WITHIN 6 MONTHS OF THE DATE OF THE EVENT.
22. All paddocks, lunge arenas, and arenas are STRICTLY out of bounds, with the exception of clearly demarcated competition arenas.
23. No holding Paddocks may be erected on the Show Grounds.
24. Dogs must be on leads at all times.

## CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
