MEMBERSHIP	None required on levies or affiliation. It is not compulsory to ride all three parts of the series, riders may also elect to only compete in the XC or SJ but entry fees remain the same.				
PRIZE MONEY	Each level will compete over the three part series for the pot of gold. Minimum 50% of class entry fees received per level with a <b>Minimum R1000 per class guaranteed pay out for series winners.</b> Prizes/rosettes for Day winners				
GROUND & ADMIN LEVY	R50 per horse (DMRC Member) R100 per horse (non-members)				
STABLES	R100 per stable; per horse per night. First paid basis.				
TIMETABLE	Saturday 30 <sup>th</sup> April Course open to walk 13h00. Riders entered in Classes 1-3 and 'Lead Me' Class may enjoy a supervised mounted course walk. Horses/ponies may only walk and may not jump any obstacle whether part of the course or not.  Sunday 1 <sup>st</sup> May 09h00 Rider briefing 09h30 XC followed by Show Jumping then drinks at the leader board.				
NOTICE	There will be a training <b>dressage and Show Jumping</b> show on <b>Saturday</b> for those wishing to make a weekend of it. Please see schedules. We have planned it to include eventing tests for those needing a practice before Underberg Eventing two weeks later. We will use this format for all 3 parts of the series and link it to the Eventing that follows after each part of the Hunter Trials Series.				
CATERING	Catering will be available Saturday and Sunday. Please support the Club.

#### **GENERAL RULES AND REGULATIONS**

- 1. We regret that no horse may enter the show without a horse flu vaccination and AHS, please complete details (date & batch number) on entry form. Flu vacs must have been administered within 6 months prior to the show.
- 2. NO refunds will be made in respect of cancellations and scratchings after closing date of entries.
- 3. Times will be up on the notice board 24 hours prior to the commencement of a show, and the final programme will be e mailed to all members of the Club. Non-Members may send the club secretary an e-mail requesting the programme and it will be forwarded. NO times will be given over the phone.
- 4. Please Note: the Organizing Committee reserves the right to combine, vary, divide or cancel classes if insufficient entries are received. .
- 5. Insofar as possible, the program and conditions relating thereto will be adhered to. However, the Organizing Committee reserves the right to make alterations in the event of unfavorable weather conditions or any other unforeseen circumstances and should the show be cancelled for any reason only 50% of entry fees will be refunded. No entries will be refunded if the show is postponed.
- 6. Dolcoed Equestrian Centre nor Dolcoed Midlands Riding Club, the organizers and any officials appointed by these shall in no way be held responsible for any damage, loss, injury sustained by owners, competitors, members of the public or any other person or persons or their property at the venue for the duration of show.
- 7. Medical cards and number vests are compulsory. Every competitor needs to wear a body protector/vest.
- 8. By entering a stallion, the competitor & owner agree to the following conditions & agree to abide by the following protocol:
  - a. Competition stallions remain the responsibility of the owner & rider at all times & they are expected to have public liability against any loss, injury or damage that might be caused by the stallion.
  - b. It is the responsibility of the owner & rider to ensure that the stallion cannot exit the stable allocated to it on its own/or with the help of another horse or uninformed person.
  - c. The stallion may only be removed from the stable during the show for exercise & preparation/competition & only in the presence of a responsible handler or rider.
  - d. Under NO circumstances shall the covering of mares be allowed to take place at the venue.
  - e. All stallions must wear a yellow tag on their bridles at all times.
- 9. The show holding body reserves the right to limit entries, depending on the total number of entries received per class.
- 10. Please note that a horse or pony may not compete in more than 1 class of Hunter Trials and 2 classes of Dressage per competition day.
- 11. Riders may ride any level of dressage and the three training shows are run separately to each other, only the Hunter trials are linked.
- 12. Riders may only jump at a level that is safe for them and their horse and the Officials may insist on a combination being downgraded it they deem it unsafe for that combination in the elected height. The Show Convenor will have the final decision in any dispute.
- 13. Riders may change entry level (height of track) across the series but points will not be carried forward as part of the overall competition.
- 14. Absolutely NO DOGS allowed.
- 15. Any rider or family member who currently owes the club money will not be permitted to enter.
- 16. Whilst this is a training show ALL CLASSES WILL BE RUN UNDER ESA RULES for the XC.
- 17. All tack will be checked before commencement of cross country. As per Eventing Rule 45.4.2 and 45.7.3 protective headgear, medical cards and body protectors are obligatory for the cross country test. Surcingles are strongly recommended.
- 18. Competitors can wear any suitable clothing, jackets not required. Safety regulations must be adhered to.
- 19. Ponies/horses may compete from the 1 August of the calendar year in which they reach the age of 4 years for Class 1 and 5 years for above.
- 20. Any horse that has not been officially entered for the event will not be allowed access to the show grounds without prior permission from the Show convenor
- 21. Numbers are to be collected before the cross country test and to be worn for both tests.
- 22. Mistreatment/Abuse of horses in any form will result in elimination.
- 23. No Adult/Junior is allowed to warm up a child's pony on the day of the show. Anyone doing so will result in the child being eliminated.

Cross Country: Distance: 1600m, Speed: 400mpm, Height: 60cm

Showjumping: Max height: 65cm, Speed: 325mpm

**CLASS 3: I'M GETTING BETTER** 

Cross Country: Distance: 1800m, Speed: 420mpm, Height: 70cm

Showjumping: Max height: 75cm, Speed: 325mpm

CLASS 4: I'M QUITE GOOD

Cross Country: Distance: 1925m, Speed: 435mpm, Height: 80cm

Showjumping: Max height: 85cm, Speed: 325mpm

CLASS 5 I CAN DO THIS

Cross Country: Distance: 2115m, Speed: 450mpm, Height: 90cm

Showjumping: Max height: 95cm, Speed: 325mpm

CLASS 6: WAYHAY - OFF WE GO

Cross Country: Distance: 2500m, Speed: 450mpm, Height: 100cm

Showjumping: Max height: 105cm, Speed: 350mpm

**CLASS 7: LEAD ME** (in the arenas)

Cross Country: Distance: 600m, Speed: 350mpm, Height: pole - 30cm

Showjumping: Max height: 30cm, Speed: 280mpm

horse.
