General Rules:

- 1. All classes will be run under NAMEF Eventing Rules.
- 2. All horses /riders must register with Namef and are required to qualify under NAMEF R&R 5.5
- 3. All entry forms from members of another Federation must be signed by their Federation secretary.
- 4. All tack will be checked before the commencement of each test. As per NAMEF5.7.10, protective headgear, medical cards and body protectors are compulsory for the cross country test. Surcingles are strongly recommended.
- 5. Clothing must comply with the relevant NAMEF Rules & Regulations 5.7.9.
- 6. Protests lodged must adhere to NAMEF Regulations.
- 7. The organizing committee reserves the right to restrict class entries strictly on a first come basis.
- 8. Faxed entries will only be accepted if accompanied by a stamped deposit slip, EFT, which should clearly state the rider's name, horse name.

- It is the responsibility of the competitor to make sure their entries have been received. Dressage tests used are from the SA Eventing and can be downloaded on the following websites: http://www.namef.org.na/index.php?cat=eventing&sub=5
- 10. The Organizers reserve the right to cancel, combine or restrict classes. Amend the time schedule mentioned in the program. Change the starting order of riders and their horses in case of need, with the approval of the technical delegate.
- 11. Horses may compete in eventing competitions from the 1st August of the calendar year in which they reach the age listed below:

EV 70	Four Years
EV 80	Four years
EV 90	Five years
EV 100	Five Years

- 12. The cross country courses will be open for inspection on foot from 15h00, 4th August 2017. This is regarded as the official starting time of the event so all eventing rules (including restrictions with regard to dress and saddlery) will be enforced. At the event venue and after the official opening of the courses for inspection, and for the duration of the event, it is forbidden under penalty of disqualification for anyone other than the competitor who will ride the horse in the competition to school a horse.
- 13. As from the 4th August 2017, no competitor /competing horse may ride in the vicinity of the cross country obstacles, until called upon to do so under penalty of disqualification. Rider numbers will be handed out at the riders briefing and are to be worn for all 3 tests. All competitors are reminded that national membership numbers must be displayed on their horse at all times while competing.
- 14. Competitors please note that medical aid cards are compulsory and a copy of the medical aid card must accompany the entry form for the national classes, but it is not compulsory for FEI anymore.
- 15. ALL DOGS MUST BE ON LEADS.
- 16. No dressage test will be supplied so competitors must ensure that they have the correct copies.
- 17. All horses must be accompanied by their updated horse passports, which must be handed over to the show organiser at the riders briefing.
- 18. Catering will be available for the duration of the tournament
- 19. NO CHANGES BETWEEN CLASSES WILL BE ALLOWED AFTER THE CLOSING DATE OF ENTRIES. HORSES MAY ONLY START IN ONE CLASS.
- 20. It is important that each entrant provides a fence judge and if possible, a WILLING HELPER. Without fence judges there will be no show. Please state the name of your fence judge on the entry form.
- 21. Any entry received with incorrect entry fees will not be accepted and may be returned to the entrant without being included in the show.
- 22. Riders falling at any point on the Cross Country course may NOT remount and must present themselves at the Ambulance for a check over.
- 23. Competitors riding more than one horse in a class may nominate which horse they want to ride first on the entry form. If they do not do this they must ride them in the order in which they are drawn.

Neither FEI, NAMEF, RGO, officials or representatives as well as the organizers shall in any way be held responsible for any loss, damage, theft, or injury sustained by horses, riders, the public or their property at the show, caused by, or resulting from this show.

The Competitor undertakes not to bring any horse to the show which has or might have an infectious disease, whether notifiable or not.

It is the responsibility of the competitor to withdraw such a horse from the event.
