## **CODE OF CONDUCT FOR THE WELFARE OF THE HORSE**

*The Fédération Equestre Internationale (FEI) expects all those involved in International Equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.*

- 1. At all stages during the preparation and training of competition, horses' welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.*
- 2. Horses and athletes must be fit, competent and in good health, before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.*
- 3. Events must not prejudice horse welfare. This involved paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the Event.*
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper Veterinary care, competition injuries, euthanasia and retirement.*
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.*
- 6. Athletes, Members and Affiliates to Eventing SA must ensure that they have read and understand the Social Media Policy which can be found on the ESA website [www.eventingsa.co.za](http://www.eventingsa.co.za) under documents/eventing rules.*

## RULES AND REGULATIONS

1. All classes will be run under ESA Eventing Rules as at 1 January 2020.
2. All tack will be checked before the commencement of each test. As per Eventing Rules 05.4.2 and 05.7.2, protective headgear, medical cards and body protectors are obligatory for the Cross Country Surcingle and are strongly recommended.
3. Competitors shall wear the correct dress at all times whilst warming up and in the arena.
4. Protests lodged must adhere to Appendix GR/D of the SAEF General Regulations and Section 03 of the Eventing Rules.
5. Entries should be done online on the ESA Website: [www.eventingsa.co.za](http://www.eventingsa.co.za). Please use the Rider's name & your invoice number as reference.
6. Any requests for a specific riding order **MUST** be emailed to the SHB. It is the responsibility of the competitor to make sure their entries have been received. The dressage tests used are from the 2010/2011 Eventing Dressage Tests available on the ESA website [www.eventingsa.co.za](http://www.eventingsa.co.za) and FEI Tests updated 2020 which can be found on the FEI website [www.fei.org](http://www.fei.org), or ESA Website.
7. The Show Holding Body reserves the right to alter or vary the programme in light of prevailing Conditions, at their discretion, with the approval of the Technical Delegate.
8. The Organising Committee, the Show Holding Body, ESA, SAEF, FEI and Windsong Event Center cannot be held liable for any loss, damage, death or injury to people, horses or property whatsoever. All competitors and spectators enter the premises entirely at their own risk. All Unaffiliated athletes must sign the annual indemnity form before entering any events.
9. The Cross-Country courses will be open for inspection on foot from 14:00 on Friday 24<sup>th</sup> April 2020. This is regarded as the official starting time of the event so all Eventing rules including restrictions with regard to dress and saddlery) will be enforced. At the event venue and after the official opening of the courses for inspection, and for the duration of the event, it is forbidden under penalty of disqualification for anyone, other than the competitor who will ride the horse in the competition, to school a horse.
10. **As from the 13 April 2020 in the Schedule, no competitor/competing horse may ride in the vicinity of the cross-country obstacles, until called upon to do so under penalty of elimination.**
11. **Any horse that has not been officially entered for the event will not be allowed access to the grounds without prior permission from the Chairman of the Organising Committee.**
12. **Numbers are to be collected before the Dressage Test and are to be worn for all 3 Tests.**
13. Competitors please note that Medical cards /other forms of medical tags are compulsory for the Cross-Country phase and medical details MUST also be updated on the Eventing SA Website.
14. Parking in designated areas only. **Dogs must be on Leads (there will be a FINE of R50 for unleashed dogs)**
15. A complete list of Veterinary Regulations, Eventing Rules and Eventing Dressage Tests can be found on [www.eventingsa.co.za](http://www.eventingsa.co.za). No dressage test will be supplied so competitors must ensure that they have the correct copies.
16. All stallions must have a yellow disc on both sides of the bridle or have a yellow ribbon in the tail.

## **WINDSONG FARM**

Situated midway between PE and East London, offers 26 hectares of pristine bushveld, forestry and a dam. Cross country tracks are built on permanent grass/sandy soil offering good going all year around.

The natural dam in the centre of the property offers the opportunity to school your horses through standing water. The surrounding area offers the option of a 5km trail through bushveld and farmland.

40+ shaded horse camps are available at R70 (per night) each as well as 5 stables at R150 (per night) each, reserved on a first come first paid basis. Thereafter bring own camp facility. Please provide own fodder.

Self-catering accommodation is available nearby. Alternatively, camping sites at Windsong are available at R50 per person per night. There is a list of nearby accommodation at the end of this document.

Food and beverages will be available during the day – Saturday and Sunday, please support our caterers!

Dogs are welcome but must be kept on a lead as we are on a nature reserve

## **DIRECTIONS TO WINDSONG**

**From Port Elizabeth**, continue 20km from Port Alfred in East London direction on the R72. 3kms past Kleinemonde take left hand turn off tar to dirt, signposted 'Shaw Park' Road (opposite the turn off to the Fish River Lighthouse). Continue on gravel for 2kms, pass Pegasus Equestrian centre on your left. Immediately after Pegasus fencing take 2<sup>nd</sup> left into dirt driveway (Windsong clearly marked), keeping fencing on your left. Parking areas for cars and horse boxes will be demarcated.

**From East London**, 6kms after Fish River Sun, look for the right turn from tar to gravel signed 'Shaw Park' Road. Turn right and follow as above for Windsong Farm.
