#### **FEEDBACK**

##### **1. National Learners Records Database (NLRD)**

We are required to upload the information of our newly registered professionals twice a year.

The information relates to the two professional designations that are registered with the SA Qualifications Authority (SAQA)

viz: Equine Practitioner – a qualified person who earns all or part of their livelihood from working with horses, but not necessarily riding them e.g. at National Qualification Framework (NQF) Level 1, a professional groom or at National Qualifications Framework (NQF) Level 4, an apprentice farrier. An Equestrian practitioner - is a qualified person who earns all or part of their livelihood from applying their skills of riding a horse e.g. an Equestrian competition coach/Instructor; an Equestrian tourism lead guide; a mounted policeman; a jockey etc. Please disregard the incorrect information that is circulating: an Equine Practitioner is NOT a qualification. It is a registered professional designation with SAQA.

##### **2. MOU with SAEF**

Regrettably, there has been no response from SAEF to the draft co-operation agreement we submitted to them for comment in July 2018. We still hope cooperation will be possible in 2020.
